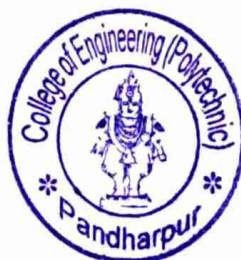

1. Introduction

- 1) This policy is in support of the broader Institutional values, especially those relating to delivering of world-class learning and teaching and developing the individual.
- 2) This Policy sets out the guidelines that underpin continuing professional development at the Institute.
- 3) This document should be read alongside the 'Pandharpur Pattern in Professional Education (PPPE)' document, which highlights Teacher's Development aspects in greater detail.

2. Purpose and Aims

- 1) The purpose of this policy is to outline the various measures taken and the aligned incentives provided by the institute for furthering teacher development.
- 2) To create awareness about the various developmental initiatives, so that it can reach each and every employee of the institute and can be availed in a fair and equitable manner.
- 3) Its aim is to increase the quality of teaching in the institute by enduring the overall development of the staff in terms of Pedagogy, Research, Teaching-Learning Skills, Communication, Soft Skills, ICT, etc.

3. Scope

This policy applies to all employees of the Institute with focus on faculty members.

4. Policy Statement

A) Internal Activities

- 1) Faculty Induction program for the newly joined faculty in the institute to make them well versed with various aspects of the Institute, its culture and unique teaching learning process
- 2) Institute conducts faculty development programs (FDPs), workshops and seminars to upgrade and update employees in a knowledge society.

- 3) Individual departments in the Institute organize Short Term Training Programs on newer developments and thrust areas in their concerned fields.
- 4) The institute organizes an International conference 'Techno-societal' once in two years addressing, evolving, developing technologies for greater societal good and rural development.

B) External Activities

- 1) The institute actively promotes participation of teachers in national, international conferences, seminars, workshops and symposiums and supports them financially as mentioned in the circulars attached in Annexures 1 and 3.
- 2) The institute encourages teachers to attend FDPs and NPTEL/ SWAYAM/MOOCs and Coursera online courses and provides financial support for the same as mentioned in circular attached in Annexure 2.
- 3) The Institute provides duty leave to teachers for industrial internship program for a period of one month at the end of academic activities of each semester.
